#### Guidance Notes on the use of The Request for Quotation Document

- 1. These guidance notes have been prepared by the CPTU to assist a Procuring Entity in the preparation of Quotation document, using the Standard Request for Quotation, SRFQ, for the procurement of low value simple, off-the-self, low value Goods and related services. All concerned are advised to refer to the Public Procurement Rules, 2008 issued to supplement the Public Procurement Act, 2006; available on CPTU's website: http://www.cptu.gov.bd/. Guidance notes are provided for both the Procuring Entity and the Quotationer.
- 2. The procurement under Request for Quotation Method (RFQM) shall follow the provisions pursuant to Rules 69 to 73 of the Public Procurement Rules, 2008 in accordance with Section 32 of the Public Procurement Act, 2006.SRFQ is based upon best national practices that have been adapted to suit the particular needs of procurement.
- **3.** The use of SRFQ (**PG1**) applies when a Procuring Entity intends to select a Quotationer (a Supplier) for the Procurement of Goods and related services under RFQ Method (RFQM)pursuant to Rule 69(3) of the Public Procurement Rules, 2008.
- 4. Pursuant to Rule 71(1) and Rule 71(2) of the Public Procurement Rules, 2008, RFQ shall be invited through letter, Fax and e-mail. RFQ shall not be required to be advertised in the daily newspapers but for the minimum circulation the Procuring Entity shall publish that advertisement in its website (if any), including posting in the Notice Board and, shall send with request for publication to the administrative wing of some other Procuring Entities nearby.
- 5. Pursuant to Rule 71(3) of the Public Procurement Rules, 2008, RFQ Document shall be issued or made available to potential Quotationers 'free-of-cost'.
- 6. The time-limit for Request for Quotation shall in no case exceed ten (10) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008.
- 7. No Securities such as Quotation Security (i.e. the traditionally termed Earnest Money, Tender Security) and Performance Security shall be required pursuant to Rule 70(6) of the Public Procurement Rules, 2008.
- 8. Submission, Opening and Evaluation of the Quotations shall respectively be dealt with pursuant to Rule 72(1), Rule 72(2) and Rule73(1) of the Public Procurement Rules, 2008 as specified in RFQ.
- **9.** The criteria for evaluation, pursuant to Rule 70(4) of the Public Procurement Rules, 2008, shall be pre-disclosed.
- **10.** Pursuant to Rule 69(5) of the Public Procurement Rules, 2008 the Quotation for standard off-theshelf low value readily available Goods and related services shall usually be on **'Unit-Rate'** basis.
- **11.** The specifications of Goods and related services shall be framed pursuant to Rule 29 of the Public Procurement Rules, 2008.
- **12.** Splitting the object of Procurement is not permissible pursuant to Rule 69(4) (ka)of the Public Procurement Rules, 2008.
- **13.** The Procuring Entity shall issue the Purchase Order, pursuant to Rule 73(5) of the Public Procurement Rules, 2008, to the successful Quotationer following recommendations of the Evaluation Committee and approval thereupon of the Approving Authority.
- 14. The Warranty Period shall usually remain between 3 and 6 months; where applicable.
- **15.** The Procuring Entity shall further be required to maintain the record of procurement proceedings pursuant to Rule 43 of the Public Procurement Rules, 2008.

Quotations received by fax or through electronic mail shall be sealed-enveloped by the Procuring Entity duly marked as stated in **Para 6** above and all Quotations thus received shall be sent to the Evaluation Committee for evaluation, without opening, by the same date of closing the Quotation.
- The Procuring Entity may extend the deadline for submission of Quotations on justifiably acceptable grounds duly recorded subject to threshold of ten (10) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008.
- 9. All Quotations must be valid for a period of at least 15 days from the closing date of the Quotation.
- 10. No public opening of Quotations received by the closing date shall be held.
- 11. Quotationer's rates or prices shall be inclusive of profit and overhead and, all kinds of taxes, duties, fees, levies, and other charges to be paid under the Applicable Law, if the Contract is awarded.

# Terms and Conditions for

## Upgradation of existing website of Bangladesh Election Commission and Payment

- 1. Terms and Conditions contained herein shall be binding upon both the Procuring Entity and the Supplier for the purpose of administration and management of this Contract.
- 2. Implementation and interpretation of these Terms and Conditions shall, in general, be under the purview of the Public Procurement Act, 2006 and the Public Procurement Rules, 2008.
- 3. The Supplier shall have to complete the delivery in all respects within 15 days of issuing the Purchase Order in conformity with the Terms and Conditions.
- 4. The Supplier shall be entitled to an extension of the Delivery Schedule if the Procuring Entity delays in receiving the **Up gradation of existing website of Bangladesh Election Commission** and related services or if Force Majeure situation occurs or for any other reasons acceptable to the Procuring Entity on justifiable grounds duly recorded.
- 5. All delivery under the Contract shall at all times be open to examination, inspection, measurements, testing, commissioning, and supervision of the Procuring Entity or his/her authorized representative.
- 6. The Procuring Entity shall check and verify the delivery made by the Supplier in conformity with the Technical Specifications and notify the Supplier of any Defects found.
- 7. If the **Up gradation of existing website of Bangladesh Election Commission** are found to be defective or otherwise not in accordance with the specifications, the Procuring Entity may reject the supplies by giving due notice to the Supplier, with reasons.

# **Technical Specification**

## **Requirements:**

The followings are lists of requirements for the design and development of the citizen portals of Bangladesh Election Commission (BEC):

## Frontend Requirements:

- Design layout for the BEC citizen portals should be created first and after the approval of the design layout, the PSD mockups should be created based on those layouts.
- Once the PSD mockups are created and approved once the feedback on those PSD mockups are implemented successfully, the PSD should be converted to HTML/CSS using the cutting edge responsive web design and development technologies and methods.
- The system analysis should be performed on the existing BEC websites and the newly created PSD mockups to find out the required JavaScript modules. Once the JS modules are listed, they should be implemented on the HTML/CSS version of the BEC citizen portal.
- Responsive layout optimization across devices should be ensured since the portals are expected to be accessed and used by the Bangladeshi citizens from a range of various different devices such as desktop, notebooks, tablets, mobile browsers etc.

- Cross-browser compatibility testing should be rigorously performed to make sure that the website is compatible with any modern browsers such as Apple Safari, Microsoft Edge, Google Chrome, Opera, and Mozilla Firefox etc.

#### Backend Requirements:

- CMS configuration A fully featured content management system (CMS) should be configured and implemented into the BEC citizen portal for the purpose of administration of the websites and making changes to the contents of the website that are being displayed to the public.
- Frontend layout integration The frontend layout that has been designed and developed in the frontend design and development phase of the project should be integrated with the CMS module of the web application and should be made sure that these two work seamlessly with each other.
- Search module development and integration The BEC Citizen Portal websites should come with search functionalities to search for any publicly available information on the portals. The search module should be developed and integrated with the web application.
- Configuration of Web Forms Through system requirements analysis and based on the current version of the BEC citizen portals, a list of forms should be created that need to be developed and those web forms should be developed accordingly. The developed web forms should be connected to the database to store the information as well as integrated with the website frontend so that the forms are available to the Bangladeshi citizens to use as they need.
- Social sharing module integration There should be provisions for the Bangladeshi citizens i.e. the visitors of the website or portal to be able to share a page or post on social media via social sharing buttons that should be available on the selected pages and posts on the BEC Citizen Portal.
- Google Analytics integration To analyze the website traffic and visitors' demographics, the Google Analytics service should be integrated with the website. The system administrators should be given access to the Google Analytics admin portal and view the demographic data about the web portal usage.

- SEO module integration The Citizen Portal should be optimized for the Google search engine so that the relevant search strings bring in the BEC citizen portal on the first page of the search results for the Bangladeshi Citizens. The keywords and other searching criteria should be analyzed in association with the BEC personnel and implemented on the portal accordingly.
- News board, photo and video gallery etc. should be developed and integrated in accordance with the current BEC website. There should be provisions for the authorized portal administrators uploading and deleting these contents from the CMS admin panel.
- User management and access control The portal admin panel should come with a fully featured user management and access control module that should let the system administrators create, edit users, create roles and assign users to the roles etc.
- Security module integration and configuration There should be a security module implemented and integrated with the system. The security module should be properly configured to make sure that the website is well protected from the deadly hacking attacks such as Denial of Service (DDoS), JavaScript Injection (JSI) etc. Add SSL certificate at the time hosting of the site.

### Localization Requirements:

- For making sure that the web portal is compatible for both English and Bangla, multi-site should be setup and configured.
- The web portal should be configured for Bangla.
- Bangla contents that will be provided by BEC should be populated into the Bangla version of the website.

#### Testing and Deployment:

• Once the website is developed, this should be deployed to a staging server first so that the BEC personnel can use the website, give their feedback and the development team should implement all those feedback accordingly.

• Once the web portal is given the official user acceptance by BEC, the web portal then should be deployed to the main server of BEC for public use ensuring minimal downtime in between
