- 02. The terms and conditions are mentioned below:
  - a. he will start his journey for India on a convenient date near to 01 September 2019 and will return to Dhaka on a convenient date near to 07 September 2019 or an approximate date;
  - b. the Secretary, Election commission Secretariat will be accompanied by his spouse Ms. Bilkis Akter, daughter Ms. Sadia Alam Raka, son Mr. Samiul Islam & daughter-in-law Ms. Farzana Ahmed Nikita in Sri Lanka during 03-07 September 2019 and all expenditure of his family member will be borne by the Secretary himself;
  - c. the Election Commission of India will bear the hotel accommodation, food and local transport in India while the Bangladesh Election Commission will bear the Dhaka-Colombo-Bengaluru-Colombo-Dhaka international airfare & other incidental expenses. Bangladesh Election Commission will also bear the all cost of Sri Lanka tour as per governments rules;
  - d. the period of this tour and time spent for travel and transit will be treated as on duty;
  - e. he will draw his pay and allowances in local currency and no part of it should be drawn in foreign currency;
  - f. this is an official visit.
